Notice regarding the continued validity of the residence permit pursuant to Section 24 (1) of the Residence Act (AufenthG)

Dear Sir or Madam,

On 4 March 2022, the Council of the European Union adopted Implementing Decision (EU) 2022/382 determining the existence of a mass influx of displaced persons from Ukraine. On this basis, you have been granted a residence permit in accordance with Section 24(1) of the Residence Act (AufenthG).

The residence permit pursuant to Section 24 (1) of the Residence Act is valid until 4 March 2024.

In accordance with Article 1 of the Second Ordinance Amending the Ordinance on the Continued Validity of Residence Permits for Ukrainian Nationals, the continued validity of residence permits for Ukrainian nationals pursuant to Section 24 (1) of the Residence Act, including all conditions and ancillary provisions, is extended until 4 March 2027, provided that your residence permit pursuant to Section 24 (1) of the Residence Act was valid as of 1 February 2026 and that you have established your actual center of life in the Federal Republic of Germany.

This also applies to persons who are not Ukrainian nationals or who are stateless persons and who:

1. as of 24 February 2022, enjoyed international protection or equivalent national protection in Ukraine;

2. are family members of Ukrainian nationals, stateless persons, or nationals of other third countries (other than Ukraine) who, as of 24 February 2022, enjoyed international protection or equivalent national protection in Ukraine;
3. or who, as of 24 February 2022, were lawfully residing in Ukraine on the basis of a valid permanent residence permit issued under Ukrainian law.

Accordingly, your residence permit pursuant to Section 24 (1) of the Residence Act is extended by operation of law until 4 March 2027.

You are therefore not required to submit an application for the extension of your residence permit. The issued electronic residence permit remains valid; no replacement is necessary.

You are entitled to continue working on the basis of your current residence permit pursuant to Section 24 (1) of the Residence Act.
